IN THIS PRECINCT, ONLY **NUMBERS 124, 125, 139 AND 140 WERE VALID IN COLUMNS 7 AND 8. EITHER** THIS BALLOT WAS OFF BY FIVE ROWS, OR IT BELONGS VALID: POSITIONS 6, 22, TO ANOTHER PRECINCT.



THIS BALLOT IS UPSIDE **DOWN, BACKWARDS, AND SHIFTED NINE ROWS** DOWNWARD, ONLY ONE MATCHING PATTERN IS 24, 40, 46, 59, 62, 65, 78, 82, 85, 100, 124 & 140.



THE PUNCHES ON THIS **BALLOT ARE SHIFTED** FOUR ROWS DOWNWARD. **POSITION 10 WOULD HAVE COUNTED AS A VOTE** FOR RALPH NADER IF HE **HAD NOT BEEN REMOVED** FROM THE BALLOT.


